Dear participant,

You are invited to participate in a webinar organised by the Barcelona Supercomputing Center within the framework of the *Climateurope2* project, which is a coordination and support actions funded by the [Horizon Europe Programme](#).

Introduction

This information/consent form is prepared by the Partners (see Annex for more details) of the *Climateurope2* project, which aims to support the climate services community and propose standardisation procedures for future equitable and quality-assured climate services, useful for decision making in all sectors of society. The Partners are in charge of the activities to be carried out for the execution of the project. These activities include the acquisition, through different means, of personal data and relevant information from the stakeholders interested in taking part in the project (hereinafter "**Data Subjects**"), for the research and/or dissemination objectives of the project (see project website, or contact the project coordinator, for more details). These activities may be conducted through both telematic means (e.g., through interactive forms or virtual meetings) and paper-based forms (e.g., during events), as well as through live audio-video recordings.

Therefore, this information/consent form is addressed to the participants in the activity and aims to provide them information on how and why their personal data is collected and processed in this context, and who is responsible.

Data retention, storage and purposes

The following categories of personal data are requested within this activity:

- Personal data: Name, surname, gender and country of residence
- Contact data: Email address
- Work related data: Work organization, sector and position or fieldwork

The personal data will be stored digitally and processed in accordance with the General Data Protection Regulation (GDPR). The personal data of the participants collected through the activity will be stored and processed to pursue the institutional purposes listed below in order to carry out projects and scientific research.

For **activity organisation and attendance tracking purposes**, your data will be processed under the basis of legitimate interest. This includes storage and processing for institutional purposes such as attendance recording, communication of changes, updates, results, follow-ups, and announcements directly related to the activity. Also to respond to your requests, comments, and concerns, and to provide you with information regarding your personal data treatment.

In addition, please indicate to which of the following purposes you consent for the processing of your personal data:

- **Project communication:** I agree to be contacted by any Partner of the project for notifying me about project updates, results, and other announcements/activities within the framework of the project. This includes communications not strictly related to the specific activity I am attending.
- **Dissemination:** I agree to the use of the material collected from the activity (e.g. photos, videos, text) for dissemination purposes, including sharing within the project Partners and/or publicly. This may include using the material beyond the project's duration if applicable.
- **Research studies:** I agree with the execution of the necessary statistics and studies for the project objectives.
- **Future research studies:** I agree with the storage of these data in their original format for future statistical research studies outside the scope of the project. If results are used in scientific publications or are made public in another way, this will be done in such a way that my anonymity is completely safeguarded.*
- **Future contact:** I agree to be contacted in the context of future projects.

We also inform you that your information and personal data may be aggregated and/or anonymized for storage and processing, to enable future research studies within and outside the project framework.*

Data conservation

Your personal data will be stored and processed under this project. If you have authorised additional purposes (such as communication about future projects, dissemination, or future research studies), your data will be retained indefinitely unless you want to revoke your consent (see section below).

Data Subject Rights

The legal basis for the treatment of your personal data as a Data Subject for the purposes described above is represented by this information/consent form. The personal data collected within the activity may be treated, in addition to the Partners, also by external subjects involved in the realization and management of the activity. In any case, we guarantee maximum confidentiality.

Your rights as a Data Subject are as follows:

- You have the right to be informed thoroughly about the research carried out within the framework of the project and its objectives.
- You have the right to halt your participation in the activity at any time.
- You have the right to request access to your personal data, to ask for the rectification of these data, and to request for the limitation of the processing concerning them, or (where the processing is based on the legitimate interests pursued) to object to the processing. You also have the right to data portability, subject to certain conditions.

- You have the right to revoke, at any time, your consent to the treatment of your personal data if this is the legal basis for the treatment. Any revocation of consent does not affect the lawfulness of the treatment based on consent before its withdrawal.
