About the Stakeholders' perspectives webinar series

This webinar series aims to understand the needs related to climate services and their standardisation from different stakeholders' point of view. Each webinar focuses on a specific stakeholder group, aiming to learn about their experiences and requirements for the integration of climate-related information in their day-to-day activities.

Urban planning through the lens of equity

This webinar session took place on June 5, 2025, and focused on the needs for urban planning at different levels. It examined how climate services are integrated into urban policy-making, with a special emphasis on equity.

Climate change is reshaping urban landscapes, often deepening existing social inequalities. Public policies at all administrative levels – local, regional, and European – play a crucial role in addressing these challenges. This webinar brought two experts on urban planning and public administration, representing both local and European perspectives. They shared their experiences on how climate services are integrated into urban policy-making, presented good practices, and reflected on ways the climate services can be improved to help prevent or reduce inequalities exacerbated by climate change.

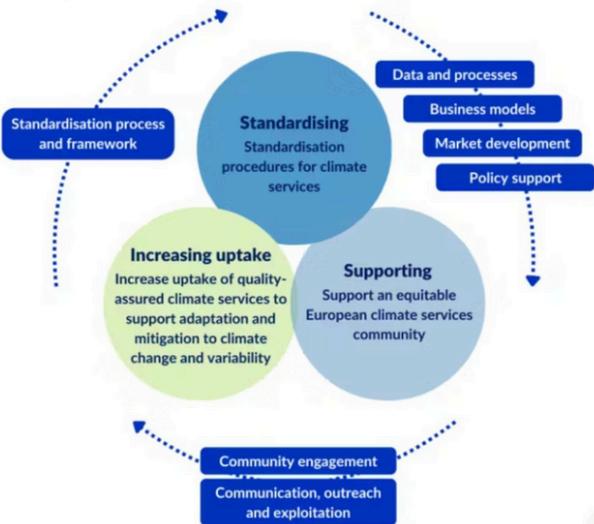

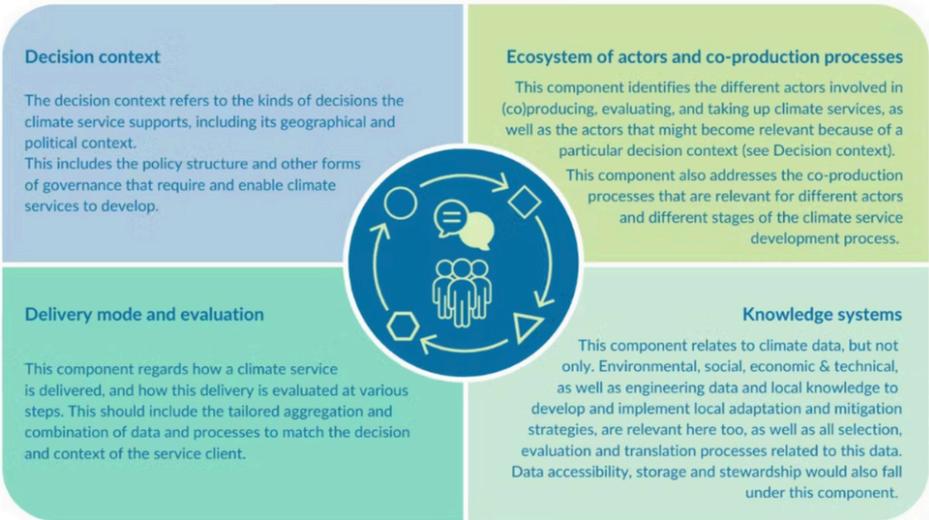

Supporting an equitable climate services community means

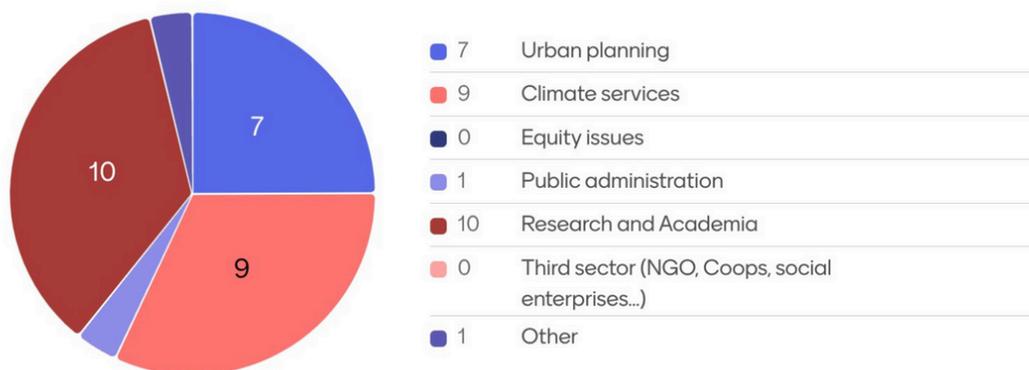
- Developing a shared understanding of equitability in climate services.

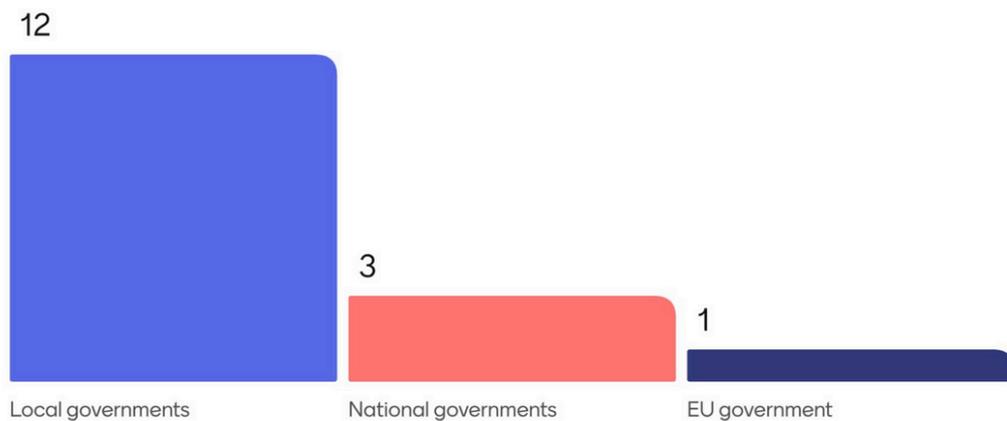

The relevance of equity in the transition to climate neutrality in cities

- The advancement of socially just climate action presents a **complex, highly contextual** challenge.
- In the energy transition context, for example, equity might mean **providing additional support to low-income households or disadvantaged communities** to ensure they can benefit from cleaner energy, lower costs, and new job opportunities.
- Equity focuses specifically on addressing disparities by **ensuring that disadvantaged individuals and groups are not disproportionately affected** by policies and have access to the benefits of these policies.





EU Mission “Climate Neutral and Smart Cities by 2030”

The objectives of the Mission are

- to achieve **100 climate-neutral and smart European cities by 2030.**
- to ensure that these cities act as experimentation and innovation hubs to **enable all European cities to follow suit by 2050.**

It will help Europe in its ambition to achieve climate neutrality by providing cities with **world-class expertise and services** tailored to their needs.

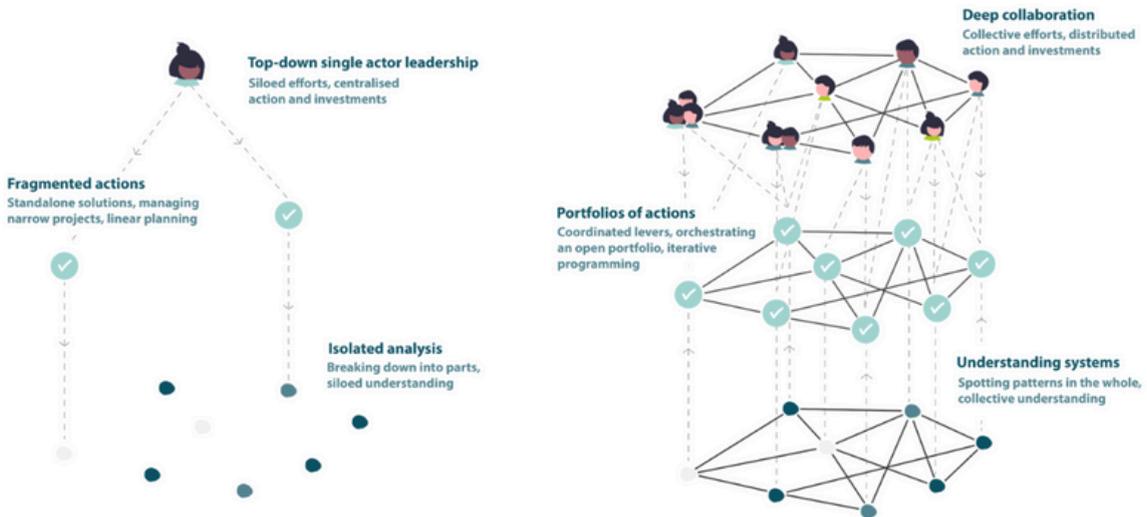

A Roadmap to Climate Neutrality

A multi-level government collaboration tool to help cities collaboratively address barriers to accelerate transformative action.

The Climate City Contract (CCC) has three interlinked components:

- Commitments
- Action Plan
- Investment Plan

Analysis from CCCs

- **Cities are incorporating justice considerations into their climate neutrality plans**, with a strong emphasis on **shared responsibilities** and **inclusive decision-making processes**. CCCs underline cities' goals to promote **shared ownership** of planned actions across the local ecosystem of actors and to ensure the **legitimacy** of the transition through participatory processes.
- **Recognition of structural inequalities as a foundation for a just transition remains limited**. Sønderborg stands out as an exception, systematically applying socio-economic data to inform its overall strategy, from the guiding principles to specific climate measures, demonstrating how **recognition of different starting points and impacts of climate change to different communities** can be integrated into climate action planning.
- **To ensure a just transition, municipalities are adopting a communication and education role**, working to foster a culture of sustainability and encourage behavioural change. At the same time, many cities describe how they are institutionalising consultative practices in both planning and implementation to embed different perspectives into their climate neutrality journey.



EU Policy Landscape

- Legislative and non-legislative initiatives and policies designed to reduce GHG emissions while considering impacts on communities.
- European Green Deal (EGD) and Fit for 55 Package
- Just Transition Mechanism
- Renewable Energy Directive (RED II) and Energy Efficiency Directive
- Social Climate Fund





The role of Multi-level Governance

- Policy is developed at multiple levels, incl. EU and National levels
 - The local level is where policy agendas intersect with residents' lives
 - How can these frameworks be aligned and coordinated better?
- Cities Mission activities, e.g. National Platforms, Policy Labs, Stakeholder Engagement



Challenges – how might Climate Services help?

- Lack of comprehensive **guidance** for municipalities in addressing specific needs of disadvantaged populations
 - Cities face **structural and administrative** challenges, e.g. limited capacity, administrative complexity, lack of long-term funding
 - Persistent **demographic and geographic inequalities**
- Need for tailored solutions to the local contexts. **Cities need to be empowered to play this tailoring role.**





Potential opportunities for increased equity

- Ensure **representation** of local governments (e.g. in development of national Social Climate Fund plans)
- Facilitate **equitable access** to funding & resources for local governments
- Ensure equity is addressed in **project proposals**
- Encourage community involvement by investing in **capacity-building programmes** for local communities
- Implement robust **monitoring and reporting** systems

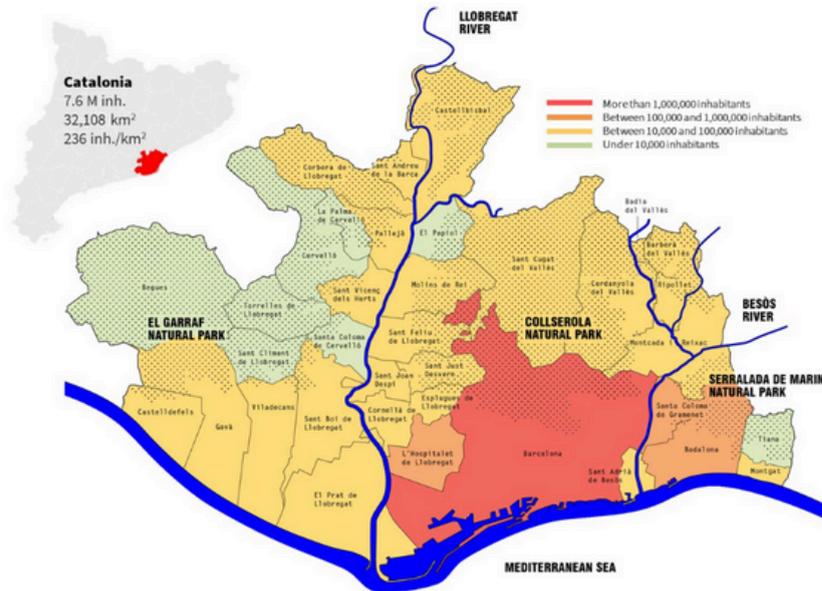

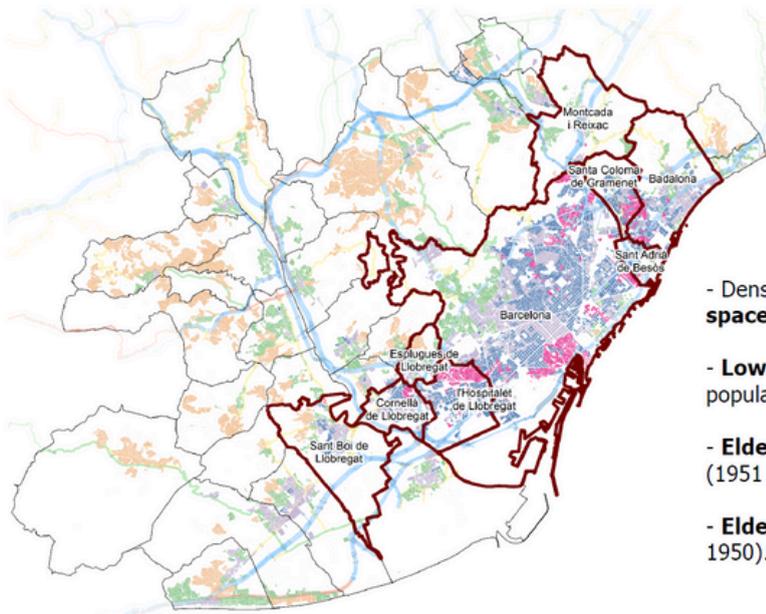

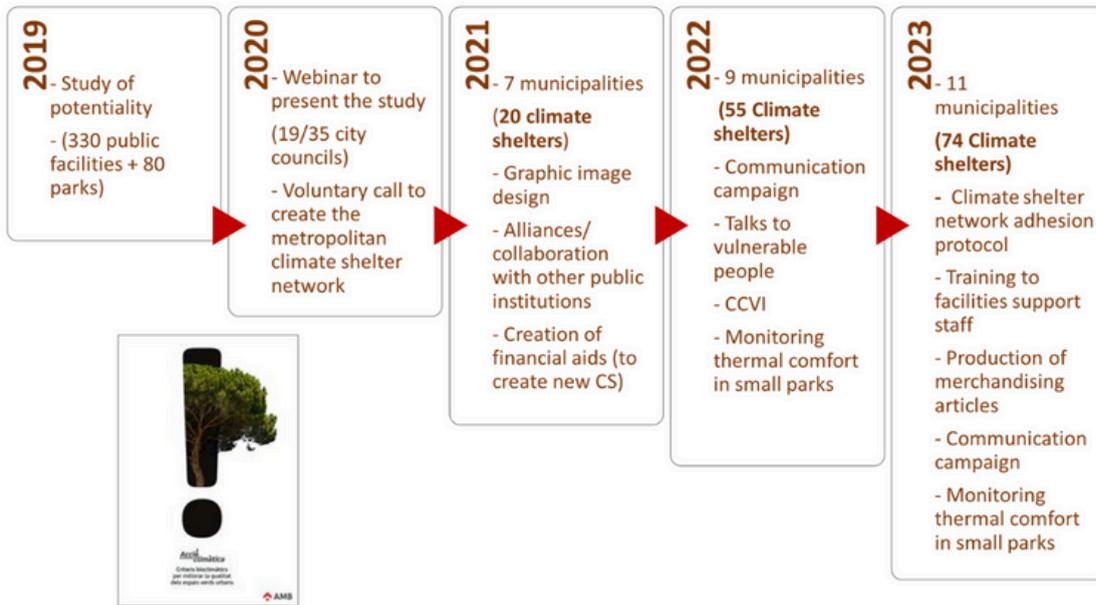


Climate Change Vulnerability Index (CCVI)

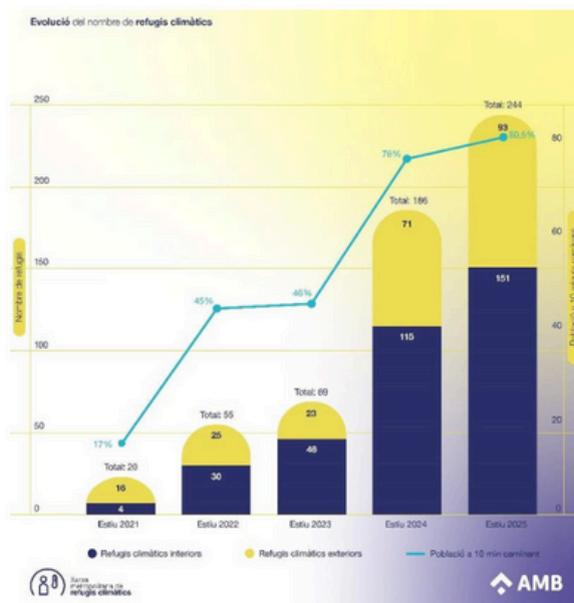


- Densely populated areas with a **lack of green spaces**.

- **Elderly people** living alone in older homes (\leq 1950).

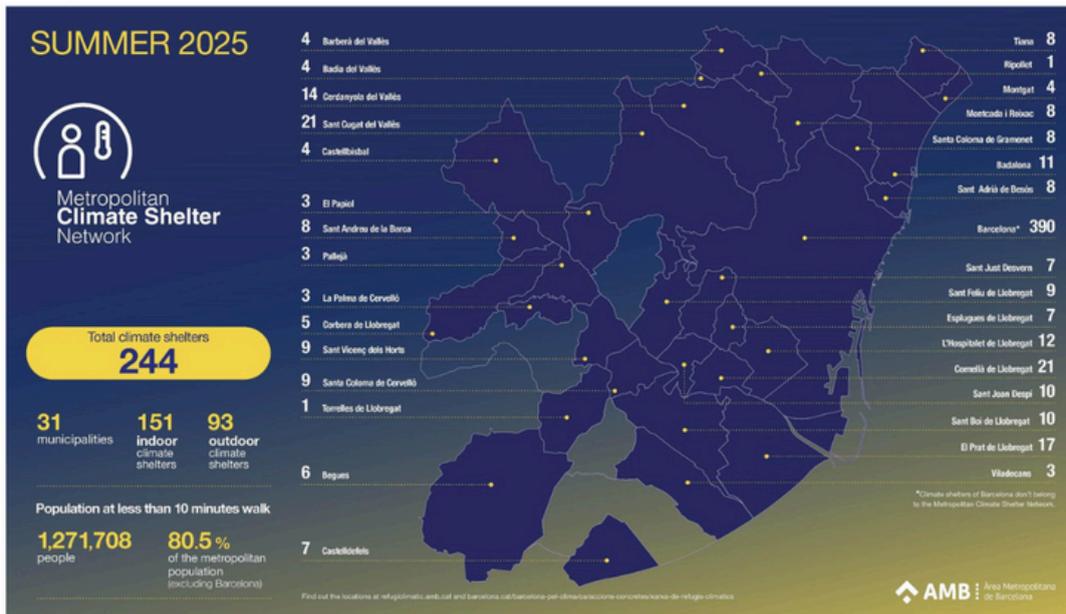

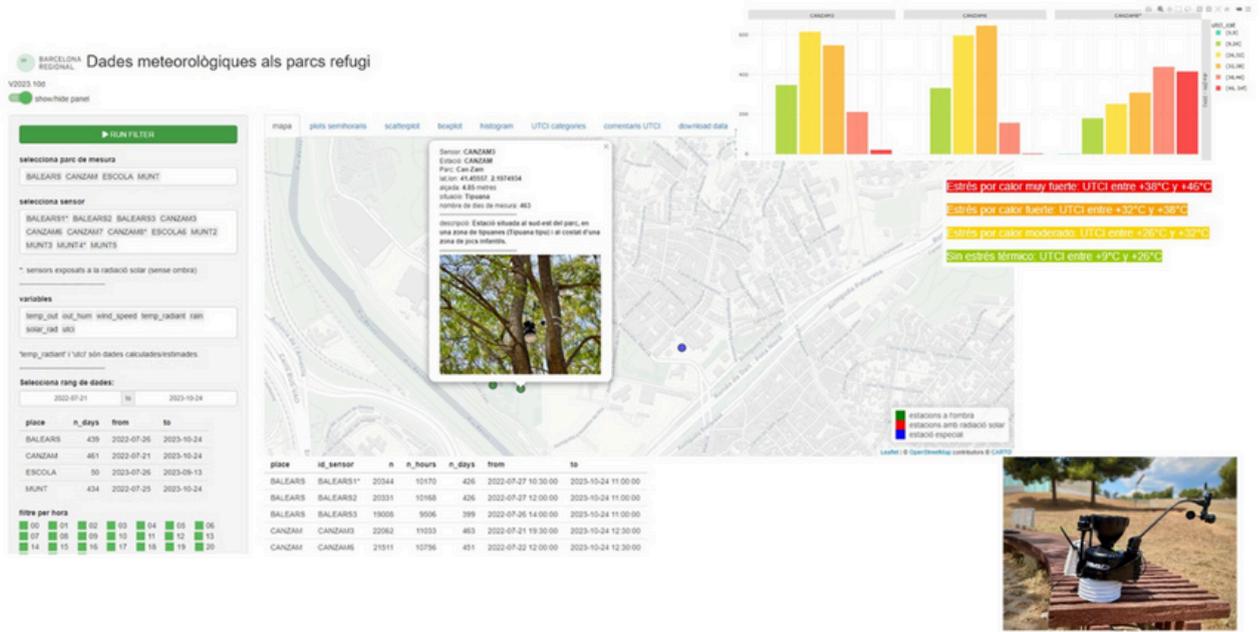

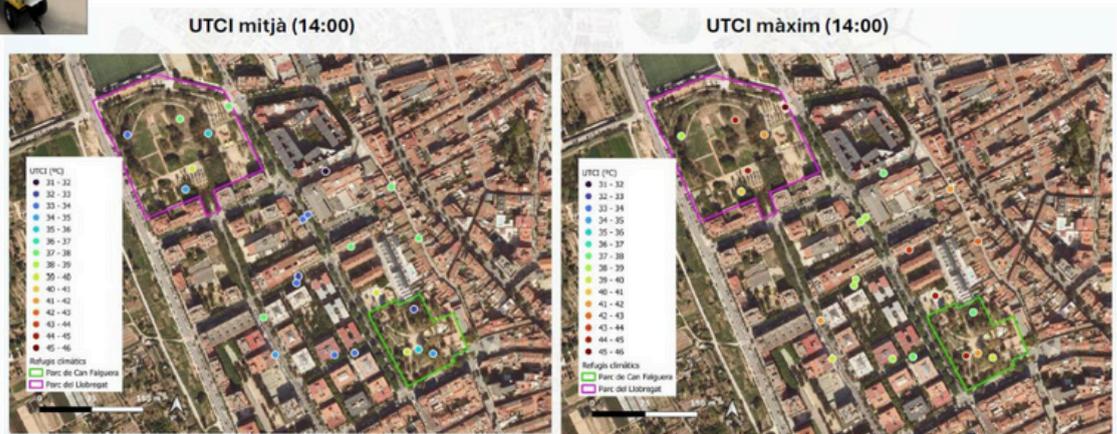
- Maintain set temperature 27°C

- Sign in a visible place, at the entrance



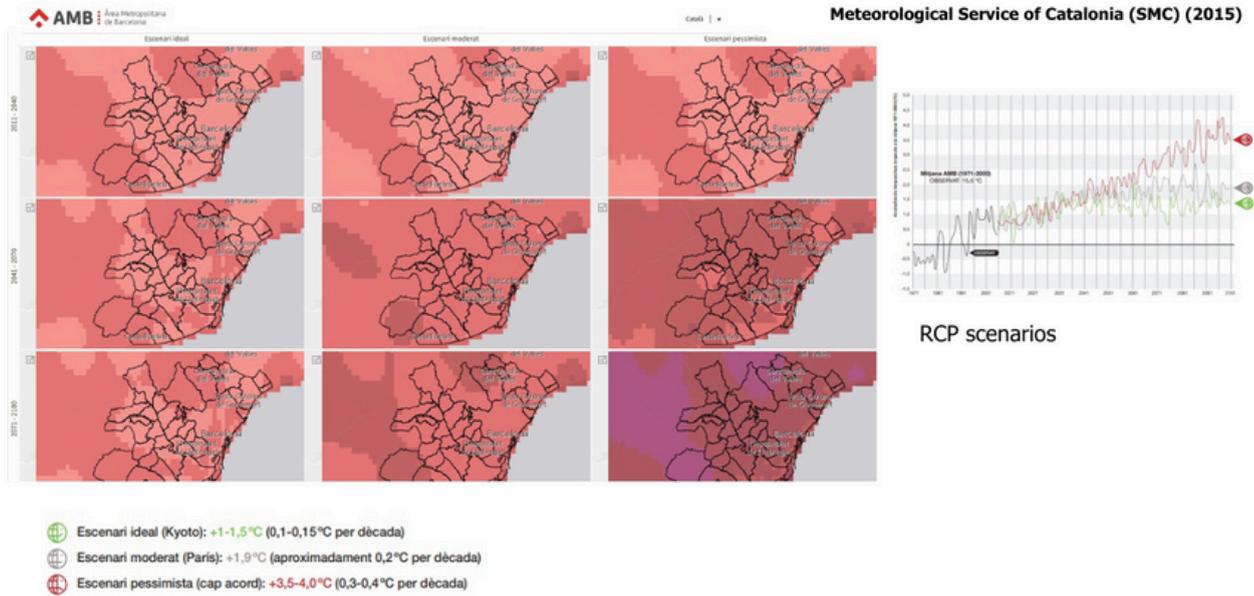
Measurement of thermal comfort in climate shelters

New Climate Scenarios



- Substantial increase in the frequency of extreme heat events .
- Largest relative increase in maximum temperature (TX) for the period 2071–2100
- Warmer nights, which may have implications for public health and nighttime thermal comfort.

Solar radiation + Public space = walkable public space that receives more than 5 hours of sunlight (between 9:30 a.m. and 7:30 p.m.)

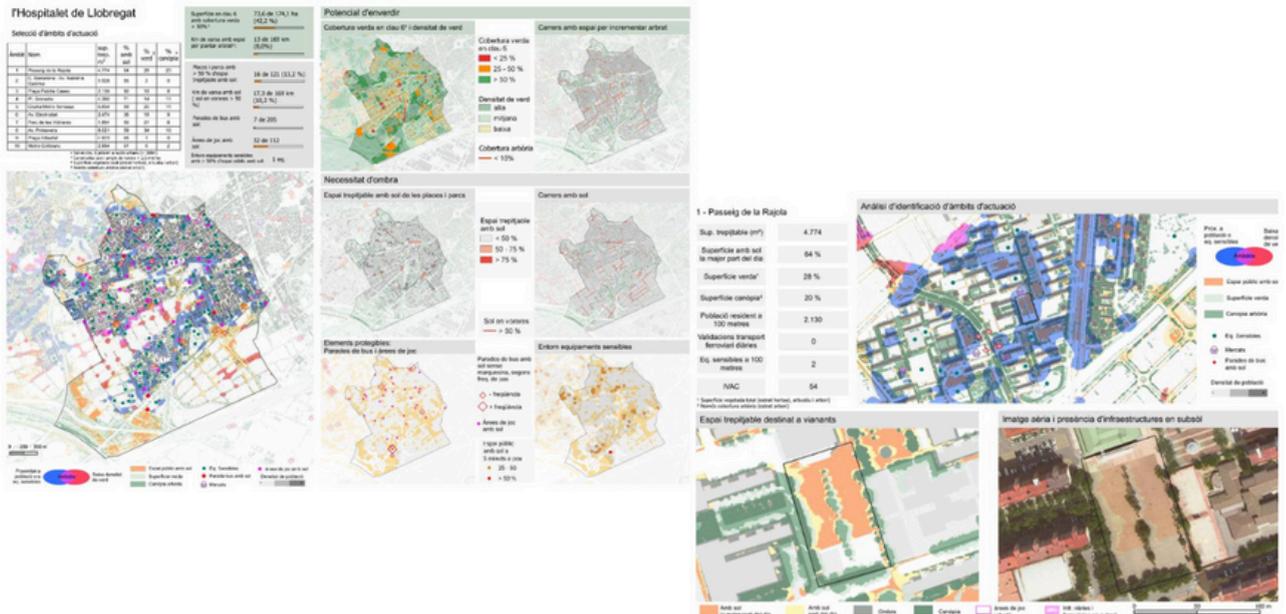

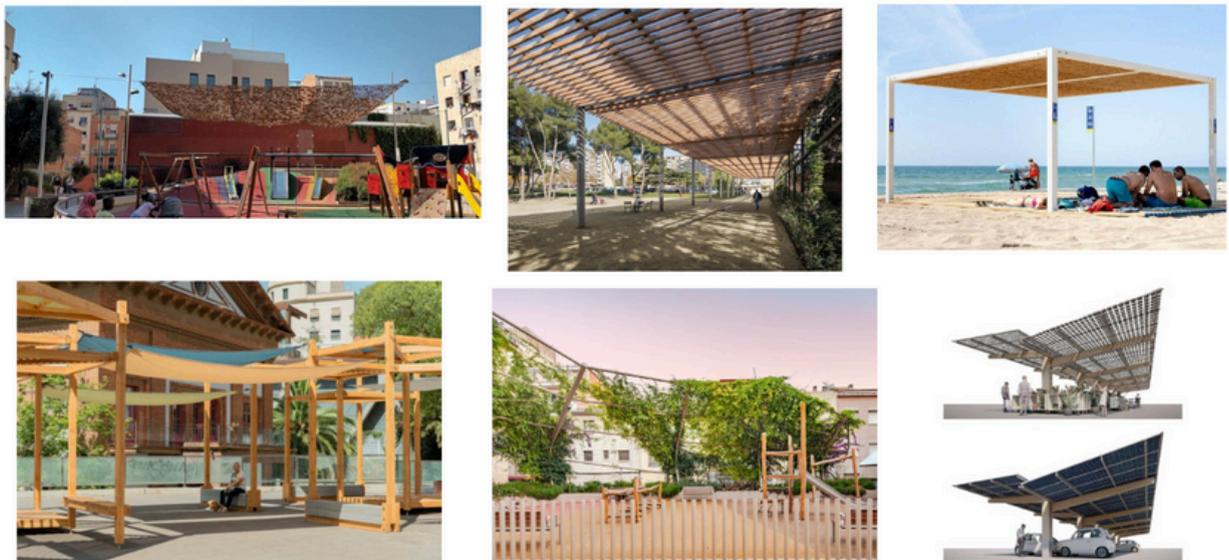


Identification of priority areas for each municipality

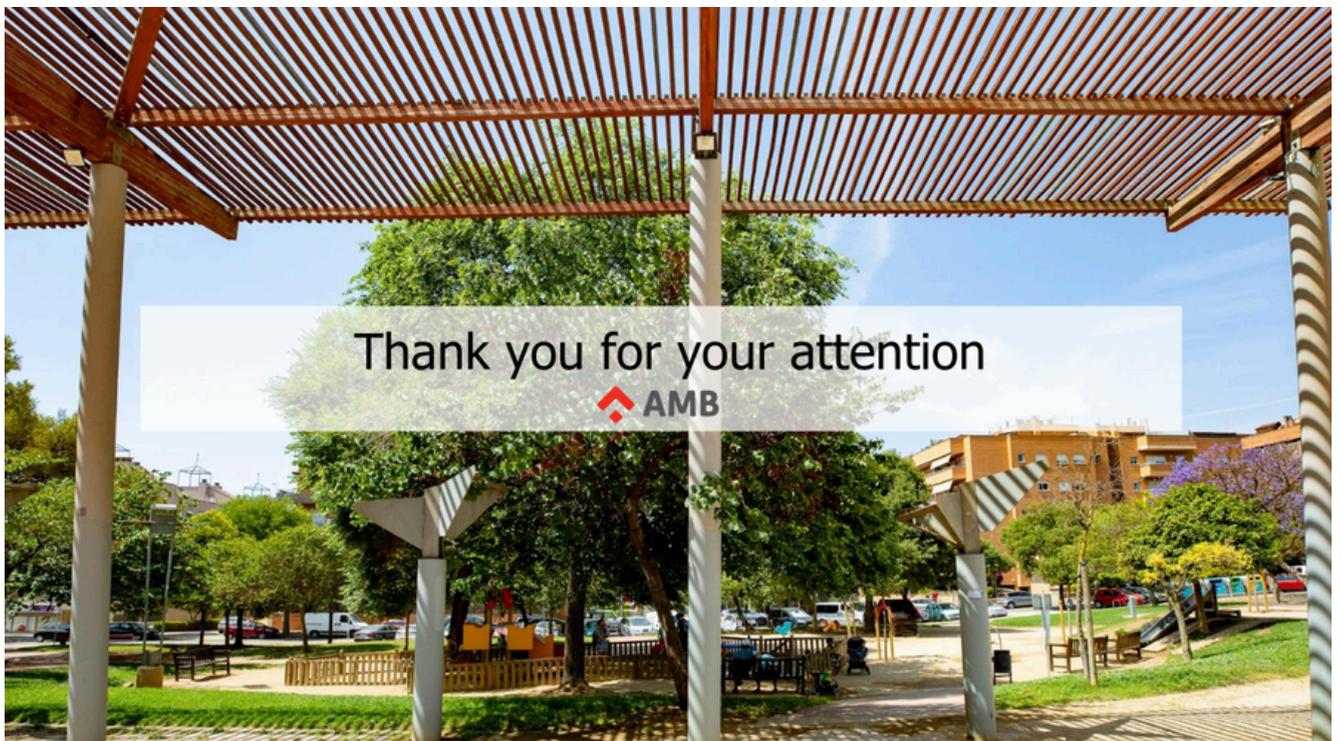

Make sure everyone has knowledge of climate relevant to their possibilities of action?

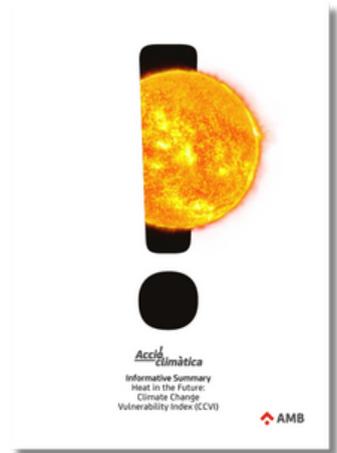
As in other fields, greater attention to the rights of particularly susceptible minorities leads to greater rights for all.

By integrating socioeconomic data with climate models, services can highlight disparities in climate exposure, vulnerability and capacity to respond.
